About our services

Q. What do you mean by within a year?

A. A year is from January to December of any given year.

Q. What if we are into 3, 6 or 9 months into the year?

A. Our 1 year still remains from January to December.

Q. How much returns am I entitled to on my investments?

A. Annual payment for single N50,000 investment (Note: once you invest more than N50,000 you automatically move to the N100,000 R.O.I plan)

Q. Where do you take your profits?

A. We take our profits by speculating and investing in viable online investments in oil, forex markets, high income yield online investments etc.

Q. How often you pay the returns?

A. You may received your first payment on next day after the completion of the 3 months.

Q. When do my investments start to count?

A Your initial investments starts to count after 1 week of your investment, this is to allow us to convert your payment in Naira into digital currency.

Q. If I make a deposit, how do you pay me?

A. All deposits are made into our bank account. We pay matured earnings directly to the investor through bank cheques. We do NOT receive or pay out cash.

Q. Can I have multiple investments of N50,000?

A. No, you can only have one investment of N50,000 at a time any other subsequent investment you make must be of N100,000 and above. If you intend to have another N50,000 investment, you will have to wait till after your 9th month collection.

Q. Can I make additional investments?

A. Yes, you can. You can make additional investments as many times as you would like provided such new investments are made afresh (i.e new forms are filled and new annual dues are paid).

Q. Can I change/swap my investment/compensation plan within my investment year?  
A. No, every plan runs for a year if you are no longer interested in continuing with your investment your investment may be terminated by the club. If you desire to invest more, then you have to start a new investment plan and pay a fresh annual dues with new form fee.

Q. What are the minimum and maximum amounts to invest?  
A. The minimum is N50,000, while maximum investment is in multiples of N50,000.

Q. Can I get back my principal?  
A. No you cannot, your principal is a sunk cost i.e invested. You are only entitled to the stated Returns On Investment R.O.I

Q. How many times am I entitled to returns on my principal?  
A. You will be entitled to return (i.e payments) after every 3 months within the investment year, which is a maximum of 4 times only in a year and your investment gets terminated.

Q. Aside from my principal is there any other payments to be made?  
A. Yes, every club member is expected to pay an additional N6,000 per annum as club dues plus N4,000 for the membership form.

Q. How do I become a member?  
A. To become a club member, you are expected to fill the membership application form which cost N4,000 (you can also download this form) then pay your proposed investment sum (minimum of N50,000 or a maximum of multiples of N50,000) and an additional N6,000 per annum, per investment plan as club dues.

If I do not collect my investment returns when due, is my investment automatically renewed?

No, if you cannot physically come to collect your investment returns when due, we suggest you send your next of kin with a letter to collect your cheque on your behalf. If you do not do this, your money would not be left pending until you fill the collection form. However we may pay your returns to a given account if you so wish at less 5% the expected amount to be received.

Can I loose money?

Yes, there is risk involved with every investment program. If your investment is terminated before our agreed one year term then you will suffer 10% loss on your principal. Also, you may loose money if the club suffers a major financial misfortune, in such a case payout to members may be affected. However, there are a few simple ways you can help reduce this risk.

Firstly, align your investments with your financial goals, in other words, keep money you may need for the short-term out of more aggressive investments, reserving those investment funds for the money you intend to grow over the long-term.

Secondly, by not investing more than what you can afford to loose. It's very important for you to know that we are real investors and that we invest members funds on major investments.

Lastly, do not go borrowing just to be a member of the club and DO NOT invest what you cannot afford to loose.

Who manages the funds?

These funds are managed by the Endless e-wealth club.

How can we offer you the guarantee?

The most important aspect of our investments, which range from low, medium to high returns are based on the fact that our principal investment is always guaranteed. If we did not have this in place, We would not feel comfortable with our money sitting in various investments - large sums usually make anyone cautious and a bit shaky around the knees.

We have been asked what we invest in...

This varies, as it largely depends on what is available at any given moment in time, but it usually includes fields like, forex, e-gold funding, selected spot trades, private placements, stock options, private equity and hedge funds.

Do I get my initial investment back?

NO you don't get your principal back, because your principal has been invested.

Termination of investment

Members CANNOT terminate their investment except in extreme cases that can only be determined by the club and in such a case the member would collect his/her principal less 10% (i.e you will collect N45,000 if you are on N50,000 plan or N90,000 if you are on N100,000 plan and if your investment is less than 3 months or you have not collected your 1st payment).

However if the investment is more than 3 months old or you have collected your 1st payment, you will have to wait till the 6th month collection for you to collect N17,500 or N35,000 and the investment gets terminated else only 10% [N5,000 or N10,000] of the principal would be paid. If you have collected the 9th month you will collect nothing back, your investment is automatically terminated.

Are there any other deductions from my earnings?

No there are not!

What happens to my investment in the event of the closure of the club?

In the event of closure of the club via unforeseen circumstances beyond the club's control. Members would be entitled to receive back a maximum of N40,000 per investment of N50,000 i.e if the member's investment is less than 3 months old but if the investment is 6 months and above nothing would be paid.

What do I do when I have a dispute with the club?

In the event of a dispute, the club rules and regulations would be applied.

Please always endeavour to study the updated club rules and agreements, its terms & conditions on our website before/when aggrieved to resolve disputes.

There would not be need for a third party intervention if we abide by these rules.

However if you still feel aggrieved then you may contact the conflict resolution committee (check members contact details on club website).
